Subject: Release of QWDX/SedLOGIN Version 1.8

The purpose of this joint Note is to announce an update of the water-quality data transfer system (QWDX) and sediment-sample login application (SedLOGIN), Version 1.8, which was released on August 28, 2015. This software update is the result of collaboration between the Office of Water Quality (OWQ), the Office of Surface Water (OSW), and the Oregon Water Science Center.

Version 1.8 of QWDX and SedLOGIN was prompted by a necessary upgrade to Oracle 11g for the databases underlying QWDX and SedLOGIN, and SedLOGIN's pending need to accommodate data from the new sediment data field application (SedWE).

Compatibility with Oracle 11g was the only major change for the QWDX Version 1.8 software. Some additional minor changes were made to the instructions and documentation for Auto Downloading, as documented in the release notes at https://qwdx.cr.usgs.gov/uo/labxfer/help/release notes.html.

In addition to compatibility with Oracle 11g, SedLOGIN Version 1.8 has these few major changes:

- SedLOGIN can import data from the new Sediment Data Field Application (SedWE).
- Parameter 04117, "Tether Line Used", is now available for Suspended Sediment samples. (It has always been available for Bedload samples, but never before for Suspended Sediment.)
- Medium OAQ (Artificial, for QC) is now available for Suspended Sediment samples, because some WSCs do field blanks for suspended sediment.

A few minor chages to SedLOGIN were also made, as documented in the release notes, at https://qwdx.cr.usgs.gov/uo/labxfer/help/release_notes.html.

Additional information:

A complete list of the changes to both QWDX and SedLOGIN is available in the release notes, which are always accessible from the on-line user manuals for QWDX and for SedLOGIN.
